

RESOLUTION NO. 7677-R54

A RESOLUTION DECLARING THE ASSUMPTION  
OF POWERS OF THE CUNNINGHAM TOWNSHIP BOARD OF TRUSTEES

WHEREAS, the Town of Cunningham (Cunningham Township) is a town which was duly organized and created pursuant to "An Act to authorize County boards in counties under township organization, to organize certain territory situated therein as a town, and to provide for annexation of territory to and the disconnecting of territory from said town", approved May 23, 1877, as amended; and

WHEREAS, said Act, as amended, currently provides that, "All the powers vested in such town, including all the powers now vested by law in the Highway Commissioners of such town and in the board of town auditors of such town, shall be exercised by the city council"; and

WHEREAS, the County Clerk, in and for the County of Champaign and State of Illinois, by certificate dated February 23, 1977, and attached hereto, has certified that the boundaries of the City of Urbana and the boundaries of Cunningham Township are coterminous both as to Voter Registration and Tax Valuation Base, all as required by law.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That all the powers now vested in and exercised by the "Board of Town Auditors" of the Town of Cunningham, which board at the time of the 1977 election of said board shall thereafter be referred to as the "Board of Trustees", shall, on and after April 18, 1977, be vested in and exercised by the City Council of the City of Urbana as required by law.


2. That the Mayor of the City of Urbana be and the same is hereby directed to send a letter, together with a copy of this resolution, to the presently constituted Board of Town Auditors of the Town of Cunningham to officially notify said board of the assumption of powers of the Cunningham Board of Trustees as herein provided.

3. That the City Clerk be and the same is hereby directed to mail copies of this resolution to all candidates for the 1977 election to the offices of City Council of the City of Urbana and of the Board of Trustees of the Town of Cunningham.


