A RESOLUTION CONCERNING CERTAIN STREET NAMES

WHEREAS, a RESOLUTION CONCERNING CERTAIN STREET NAMES was enacted by the Urbana City Council on March 1, 1971 and,

WHEREAS, item five of the said resolution designated as Bradley Avenue, the road or street lying along the South Section line of Sections 4, 5, and 6 in Township 19 North, Range 9 East of the Third Principal Meridien in Champaign County,

WHEREAS, a significant section of right of way of the road or street so designated as Bradley Avenue lies outside the limits of the City of Urbana,

WHEREAS, the City of Urbana, lacking jurisdiction to enforce the provisions of item five of the said resolution, a condition of confusion regarding prevailing street names exists.

NOW THEREFORE BE IT RESOLVED by the Urbana City Council that:

1. This City Council finds and determines that the facts contained in the above recitations are true.

2. That the Urbana City Council, on behalf of the said City, hereby rescinds item five of the said resolution of March 1, 1971.

3. That the roads or streets shall be officially designated as follows:

a. Bradley Avenue:

From the West City limit line of the City of Urbana (which is the East City limit line of the City of Champaign) Easterly approximately 2700 feet to the West right of way line of Coler Avenue.

b. Country Club Road:

From the East right of way line of Coler Avenue Easterly approximately 1100 feet, thence Southerly approximately 600 feet, thence Easterly to the West right of way line of Cunningham Avenue.

c. Perkins Road:

From the East right of way line of Cunningham Avenue, following the Southeast Quarter of Section 4, Township 19 North, Range 9 East, Third Principal Meridien; Easterly to the West right of way line of I-74.

4. That the provisions of this Resolution shall be contingent upon action by the Champaign County Board to confirm the street names so designated, and that the effective date of this designation action shall be the said date of confirmation.

A RESOLUTION CONCERNING CERTAIN STREET NAMES

WHEREAS, a condition of confusion regarding prevailing street names exists within and adjacent to the City of Urbana, and

WHEREAS, it is desirous and in the public interest to resolve this condition, and

WHEREAS, the Urbana City Council has passed a resolution to officially designate certain roads and streets as follows:

a. Bradley Avenue	From the West City limits line of the City of Urbana, Easterly approximately 2700 feet to the West right of way line of Coler Avenue.
b. County Club Road:	From the East right of way line of Coler Avenue Easterly approximately 1100 feet, thence Southerly approximately 600 feet, thence East- erly to the West right of way line of Cunning- ham Avenue.

Avenue, following the South line of Section 4, Township 19 North, Range 9 East, Third Principal Meridan; Easterly to the West right of way line of I-74.
