

PROTEST TO PROPOSED
AMENDMENT TO COUNTY ZONING ORDINANCE

WHEREAS, the Champaign County Environment Land Use Committee has proposed a textual amendment to Section 5.2 of the County Zoning Ordinance to permit storage of petroleum and gas by right in the County I-2 Zoning District; and

WHEREAS, the City of Urbana, Illinois, is a zoned municipality within the meaning of the law; and

WHEREAS, certain portions of the County I-2 Zoning District are within the one and one-half mile area contiguous to the City of Urbana; and

WHEREAS, the City of Urbana is the nearest adjacent such zoned municipality as to those portions of the County I-2 Zoning District within the one and one-half mile area contiguous to the City of Urbana; and

WHEREAS, the Urbana Plan Commission, in Plan Commission Case No. 299-AT-77 and after due consideration and study, has recommended to the City Council that the City of Urbana, Illinois, file an official protest against the adoption of such amendment because the County has little control over storage facilities for petroleum and gas other than through the State Volatile Fuels Act and because a more modern fire protection code is needed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:


