AN AGREEMENT AMENDING APPENDIX "B"  
OF THE AGREEMENT BETWEEN THE CITY OF  
URBANA, ILLINOIS AND LOCAL #1147,  
INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS,  
AFL-CIO, DATED THE 19TH DAY OF NOVEMBER, 1975

WHEREAS, Article XX, Section 20.1, entitled, "Reopening", of the Agreement entered into the 19th day of November, 1975, between the City of Urbana, Illinois, (hereinafter referred to as the "City") and Local #1147, International Association of Fire Fighters, AFL-CIO, (hereinafter referred to as the "Union"), makes provision whereby the Union may notify the City in writing of its desire to reopen the Agreement; provided such reopener shall be limited to salaries, longevity pay, leaves of absence, insurance benefits, holidays, educational incentive pay and hours of work for the year July 1, 1976 through and including June 30, 1977; and

WHEREAS, the Union duly notified the City in writing of its desire to so reopen the Agreement on May 1, 1976, a date within the period specified in Article XX, Section 20.1, of the Agreement to do so; and

WHEREAS, upon such notice being given, the duly authorized representatives of both the City and the Union met for the purpose of negotiating in good faith the items so specified for the year July 1, 1976 through and including June 30, 1977.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the City and the Union do mutually covenant and agree to amend Appendix "B" of the Agreement as follows:

Effective July 1, 1976, through and including December 31, 1976, the base salary for employees covered by this Agreement, determined herein as the annual base and represented in both annual and hourly rates (based upon 2,912 hours per year) shall be as follows:

<u>Classification</u>	<u>Annual</u>	<u>Hourly</u>
Fire Fighter	\$12,263	\$4.212
Fire Lieutenant	\$13,463	\$4.624

Effective January 1, 1977, through and including June 30, 1977, the base salary for employees covered by this Agreement, determined herein as the annual base and represented in both annual and hourly rates (based upon 2,912 hours per year) shall be as follows:



<u>Classification</u>	<u>Annual</u>	<u>Hourly</u>
Fire Fighter	\$12,631	\$4.338
Fire Lieutenant	\$13,831	\$4.75

The City and the Union both acknowledge that the foregoing amended schedules establishing the annual base salary as represented in both annual and hourly rates (based upon 2,912 hours per year) for the periods July 1, 1976 through and including December 31, 1976, and January 1, 1977 through and including June 30, 1977, constitute all of the amendments to the Agreement under Article XX, Section 20.1 of the Agreement entitled, "Reopening", and that this amendment, together with the remainder of the Agreement, shall govern the salaries and all other benefits and conditions of employment covered by this Agreement for the year July 1, 1976 through and including June 30, 1977.
