

RESOLUTION NO. 7677-R70

A RESOLUTION APPROVING A CONTRACT

and the same is hereby authorized to execute said Contract for and  
on behalf of the City of Urbana.

CONTRACT FOR PARKING SPACES

THIS AGREEMENT is made this 20th day of June, 1977, by and between the County of Champaign, Illinois, a body politic and corporate, hereinafter referred to as the COUNTY, and the City of Urbana, Illinois, a municipal corporation, hereinafter referred to as the CITY.

WITNESSETH THAT:

WHEREAS, the COUNTY has the need for additional parking spaces when petit juries are in session; and

WHEREAS, the COUNTY desires to meet that need; and

WHEREAS, the COUNTY desires to obtain additional parking spaces during the times aforesaid and the CITY is able and willing to furnish said spaces; and

WHEREAS, the COUNTY and the CITY have reached an agreement pursuant to the authority granted by the Illinois Constitution of 1970, Article 7, Section 10, whereby this objective may be accomplished.

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, it is agreed by and between the COUNTY and the CITY as follows:

1. The term of this Agreement shall extend from the date of its final execution to June 30, 1978. During the term of this Agreement, the CITY shall provide for the use of selected and prospective jurors sixty (60) parking spaces on the Lincoln Square parking lot contiguous to Elm and Vine Streets in Urbana, and/or on the Civic Center parking lot in Urbana whenever petit juries are being selected or are in session in the Champaign County Court House of Urbana, Illinois. The Clerk of the Circuit Court shall notify the CITY of the periods during which petit juries will be selected or are in session, and the CITY will provide the aforesaid parking for those periods.

2. The COUNTY will use identification badges, provided by the COUNTY, to identify jurors' cars covered by this Agreement.

3. The CITY shall refrain from enforcing parking meter restrictions with respect to said sixty (60) vehicles during the hours of 9:00 A.M. to 5:00 P.M. in the periods aforesaid, and shall void any and all tickets written on said vehicles after 5:00 P.M. in said periods upon receipt of notice from the Circuit Clerk that the vehicle ticketed was parked pursuant to this Agreement and the juror was still on duty.

4. The COUNTY shall pay to the CITY Twenty-two Dollars (\$22.00) for each day that parking is provided as per this Agreement. The COUNTY shall pay for parking provided in each calendar month, during the term of this Agreement, within Thirty (30) days of the last day of that calendar month.

5. This Agreement shall become effective when signed by the duly authorized officers, duly attested and sealed on the day and date first above written.

IN WITNESS WHEREOF, the parties hereto, pursuant to authority granted by their respective governing bodies, have caused these presents to be executed by their duly authorized officers, duly attested and their corporate or official seals, if any they have, to be hereunto affixed on the day and date first above written.
