AGREEMENT FOR APPRAISALS OF SINGLE-FAMILY  
HOMES FOR COMMUNITY DEVELOPMENT DIVISION

THIS AGREEMENT made and entered into this 27<sup>th</sup> day of June, 1977, by and between MARK REINHARDT, Realtor, hereinafter called "Realtor" and the CITY OF URBANA, a municipal corporation of the State of Illinois, hereinafter called "City".

For and in consideration of the mutual promises hereinafter set forth, it is agreed between the parties as follows:

1. Realtor agrees to appraise on request any single-family home so designated by the Director of the Community Development Division of the City. Said appraisals shall be on and in accordance with the Regulation Appraisal Form of the State of Illinois (17-ARI, Accounting Division 1072) and shall, upon completion, be delivered to said Director of the Community Development Division.

2. For the aforesaid services, the City agrees to pay Realtor the sum of fifty dollars (\$50.00) for each single-family home so appraised.

3. This agreement shall be in full force and effect from the date of commencement of services hereunder provided until June 30, 1978.
