PARTICIPATION AGREEMENT BETWEEN
THE CITY OF URBANA AND CHAMPAIGN COUNTY REGIONAL
PLANNING COMMISSION

THIS AGREEMENT made this day of , 1977 between Champaign County Regional Planning Commission, hereinafter called "Commission" and the City of Urbana, Illinois, a municipal corporation, hereinafter called "City".

WITNESSETH:

In consideration of the mutual covenants herein contained, the parties hereto agree as follows:

1. City hereby agrees to pay Commission the sum of \$65,790.00. Such sum was derived in accordance with the method provided for in the Commission's By-Laws. Such sum to be paid to the Commission in four (4) quarterly installments, of \$16,425 on July 1, 1977; October 1, 1977; January 1, 1978; April 1, 1978.
2. Commission agrees to provide a professional planning staff adequate in quantity and quality to provide the professional planning staff service required by City in accordance with the Commission work program and budget for the fiscal beginning July 1, 1977 and ending June 30 1978. Such services shall include, but not be limited to:
 - A. The review of proposed subdivision plats.
 - B. The review of petitions for rezoning of property in City and of County zoning cases in the contiguous area, and for amendment of the text of zoning ordinances of City and the making of recommendations in regard there to.
 - C. The conduct of special studies including, but not limited to, land use, neighborhood preservation analysis, school related studies and capital improvement programing of city and working with consultants on the comprehensive plan for the central area of the City, and such other studies as the Commission and the City authorizes.
 - D. The writing of agenda, minutes, resolutions, and corres-

pendence in connection with regular and special business
of the City Plan Commission.

3. If Commission is willing to furnish the services provided for herein to City during the fiscal year 1978-79, it shall, on or before June 1, 1978, advise the City of the cost of said services. If City wishes to purchase said services at the stated cost, it agrees to enter into a contract with Commission by July 1, 1978.
