


A RESOLUTION APPROVING A LETTER OF AGREEMENT

LETTER OF AGREEMENT  
BETWEEN THE COUNTY OF CHAMPAIGN  
AND  
THE CITY OF URBANA

WHEREFORE, the City of Urbana has requested financial assistance from the County of Champaign for the intermittent resurfacing of Curtis Drive and a portion of Michigan Avenue east of Curtis Drive utilizing Federal-Aid Urban S.O.S. Funds and the County Highway and Transportation Committee has considered the request, let it be known as follows:

- 1.) If the City will pay the Contractor on the basis of Payment Estimates submitted as the work progresses,
- 2.) The County will designate the improvement as a County project using Federal-Aid Urban S.O.S. Funds by adopting appropriate resolutions and provide construction engineering in accordance with State and Federal regulation.
- 3.) Upon completion of the improvement and reimbursement to the County of 70% of the final project cost from Federal-Aid Urban S.O.S. Funds, the County will reimburse the City 70% of the project cost less the County's engineering supervision costs, not to exceed 4% of the cost of the project.
