

RESOLUTION NO. 7879-R47

A RESOLUTION APPOINTING THE JUDGES THEREOF,
AND DIRECTING THE PUBLICATION OF NOTICE FOR THE
PRIMARY AND REGULAR MUNICIPAL ELECTIONS FOR
THE CITY OF URBANA, ILLINOIS

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS, as follows:

Section 1. There shall be a primary election of officers of the City of Urbana, Champaign County, Illinois, on the 13th day of February, 1979, and a regular election of officers of the City of Urbana, Champaign County, Illinois, on the 3rd day of April, 1979.

Section 2. At such election, there shall be elected a City Clerk who shall serve the balance of a four-year term beginning in 1977 and seven aldermen/alderwomen, each of which is to serve a four-year term. The ballot to be used in each such election shall be in the form prescribed by statute; and it shall be the duty of the Acting City Clerk to assure the preparation of a sufficient number of ballots for these elections, to cause a sample of such ballot to be published prior to the day of the election, and to provide the necessary election supplies for each voting ward.

Section 3. For the purpose of the said elections, the City shall be divided into seven election wards. The boundaries of such wards shall be as designated and set forth in the document, entitled "Official Ward Map of the City of Urbana, Champaign County, Illinois", a copy of which said map was adopted and approved by the City Council in Ordinance No. 7879-42 on the 23rd day of October, 1978. The polling places for each ward, and the judges of election assigned to each ward shall be as hereinafter set forth in this ordinance.

Section 4. The Acting City Clerk is hereby directed to cause notice of said elections in the form and within the dates prescribed by statute by publishing notice thereof once in the Champaign-Urbana Courier and the Champaign-Urbana News-Gazette, each being a newspaper published in and having a general circulation within the City.

Section 5. The following named persons, each of whom is a citizen of the United States and is entitled to vote at the next election; is of good repute and character; is able to speak, read and write the English language; is skilled in the four fundamental rules of arithmetic; is of good understanding and is capable; is not a candidate for office at this election and is not an elected committeeman, and who resides in the ward in which he or she is selected to act, are hereby appointed judges of election for each such election in the wards shown as follows:

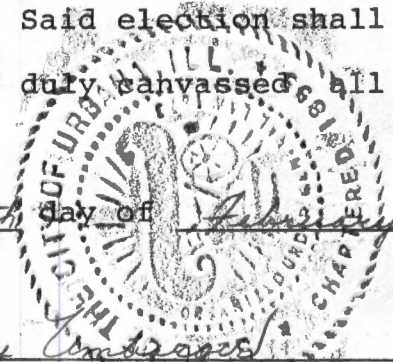
