


A RESOLUTION



Whereas, the City of Urbana has requested financial assistance from the County for the construction of Race Street from Montclair Road to Windsor Road and the County Board has passed a resolution authorizing the Chairman to sign an agreement on behalf of the County for the improvement. Therefore let it be known as follows:

1. The City will provide the right-of-way, preliminary design engineering, furnish the necessary statements and procedures required to conform with the Federal and State policies in regard to design, location, environment and right-of-way purchasing.
2. The City will upon completion of the improvement maintain or cause it to be maintained.
3. The County will designate the improvement as a County project by adopting appropriate resolutions.
4. The County will provide the \$100,000 lump sum from the County's allocation of Motor Fuel Taxes for the County's portion of the proposed improvement. \$50,000 will be paid upon award of contract. Remaining \$50,000 will be paid upon final acceptance of the completed project by FHWA.
5. The County will furnish engineering inspection during the construction and cause the improvement to be built in accordance with the approved plans, specifications and contract.




