

A RESOLUTION
DECLARING RESULTS OF SPECIAL ELECTION HELD
ON THE PROPOSITION OF WHETHER THE CITY OF
CHAMPAIGN AND THE CITY OF URBANA SHOULD BE
UNITED INTO A SINGLE MUNICIPALITY UNDER
THE NAME OF "CHAMPAIGN-URBANA"

WHEREAS, on the 4th day of November, A.D. 1980, there was held in and for the City of Urbana, Champaign County, Illinois, a special election for the purpose of submitting to the voters of the City the proposition of whether the City of Champaign, Illinois and the City of Urbana, Illinois should be united into a single municipality under the name of "Champaign-Urbana" with the council/managerial form of municipal government with two council members chosen for staggered terms from each of ten districts; and

WHEREAS, the said election has been regularly called and held as provided by law and the returns of said election, including the certificates of results and other returns of said election have been filed with the City Clerk of the City of Urbana, and the returns are now before the City Council, and the said Council is familiar therewith.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the election held on the 4th day of November, 1980, was held in all respects as provided by law. The returns of said election have been duly certified and were filed with the City Clerk of the City of Urbana.

single municipality under the name of "Champaign-Urbana" with the
council/managerial form of municipal government with two council
members chosen for staggered terms from each of ten districts
received a majority of the NO votes cast at the election, as
aforesaid, and the proposition therefore was DEFEATED and was
DISAPPROVED by the voters of the City of Urbana, Champaign County,
Illinois.
