

A RESOLUTION AUTHORIZING THE MAYOR
TO EXECUTE AN AGREEMENT BY AND BETWEEN
THE CITIES OF CHAMPAIGN AND URBANA AND THE VILLAGE OF SAVOY
PROMOTING MUTUAL DEVELOPMENT OF CABLE TELEVISION SYSTEMS

WHEREAS, the Cities of Champaign and Urbana have granted franchises to Champaign-Urbana Communications, Inc., for the installation and operation of a Community Antenna Television (CATV) System in the two Cities; and

WHEREAS, the CATV System is at this time being installed and activated in the two Cities; and

WHEREAS, the CATV System could be extended to serve residents in the Village of Savoy and the Board of Trustees of the Village of Savoy is considering the possibility of such extension; and

WHEREAS, it is in the best interest of the Cities of Champaign and Urbana and the Village of Savoy to cooperate and share expenses in the development of cable television franchises to serve the residents of their respective jurisdictions; and

WHEREAS, Section 1 of the Champaign CATV Franchise Ordinance, as amended on January 20, 1981, provides that "no such extension may be authorized or activated until such time as an Agreement has been reached and executed by and between the Cities of Champaign and Urbana, and the governmental jurisdiction into which the CATV System extension is being made, setting forth the terms and financial conditions governing such extension authorization"; and

WHEREAS, such an Agreement has been prepared which provides for the Village of Savoy to pay the sum of two thousand dollars (\$2,000) to the Cities of Champaign and Urbana as its pro-rata share of the CATV franchise development costs incurred by the two Cities; and

WHEREAS, the Champaign-Urbana Joint CATV Commission has reviewed and unanimously recommended that said Agreement be approved by the Councils of the Cities of Champaign and Urbana.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That the Agreement entitled "An Agreement by and between the Cities of Champaign and Urbana and the Village of Savoy Promoting Mutual Development of Cable Television Systems", a copy of which is attached hereto and made a part hereof, be and the same is hereby approved.

2. That the Mayor of the City of Urbana, Illinois be and the same is hereby authorized to sign and execute said Agreement for and on behalf of the City of Urbana, Illinois.

3. That the City Clerk of the City of Urbana, Illinois be and the same is hereby directed to send a certified copy of this Resolution to the Secretary of the Champaign-Urbana Joint CATV Commission.
