

RESOLUTION NO. 8182-R28

A RESOLUTION
APPROVING AN AMENDED AGREEMENT TO PROVIDE
FOR PARKING AND FOR PARKING VALIDATION
PAYMENTS, JUMER'S CASTLE LODGE PROJECT

WHEREAS, by Resolution No. 8182-R11, entitled "A Resolution Approving an Agreement to Provide for Parking and for Parking Validation Payments, Jumer's Castle Lodge Project", passed on September 8, 1981 and approved on September 11, 1981, the City Council duly approved and authorized the execution of a certain Agreement between the City of Urbana, Illinois and Jumer's Castle Lodge, Inc.; and

WHEREAS, at a regular meeting of the City Council on October 5, 1981, it was duly moved and seconded to amend the aforesaid Parking Agreement with Jumer's Castle Lodge, Inc. to provide no less than 154 parking spaces and to state that Elm Street would be no less than three lanes, which said motion was duly carried by a voice vote of the City Council; and

WHEREAS, the City Council now desires to further amend certain terms and provisions of the aforesaid Agreement, said amendments being incorporated in the Agreement attached hereto and hereby incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That the amended Agreement between the City of Urbana, Illinois and Jumer's Castle Lodge, Inc. to provide for parking and for parking validation payments, a copy of which such

amended Agreement is attached hereto and hereby incorporated by reference, be and the same is hereby approved.

2. That the Mayor of the City of Urbana, Illinois be and the same is hereby authorized to execute and the City Clerk of the City of Urbana, Illinois be and the same is hereby authorized to attest the amended Agreement between the City of Urbana, Illinois and Jumer's Castle Lodge, Inc. to provide for parking and for parking validation payments.

3. That the actions of this City Council heretofore authorizing the approval and execution of that certain Parking Agreement by Resolution No. 8182-R11 and by motion duly made, seconded and passed on October 5, 1981, be and the same are hereby repealed and rescinded, it being the intent of this City Council that the amended Agreement as approved and authorized to be executed by this Resolution be the form of the Agreement between the City of Urbana, Illinois and Jumer's Castle Lodge, Inc.
