AN AGREEMENT FOR INSTALLATION OF SANITARY SEWER

THIS AGREEMENT, entered into this 2d day of August, 1982, between the City of Urbana, Illinois, hereinafter referred to as "the City", and Eileen P. Scott, hereinafter referred to as "the Resident"; and

WHEREAS, Resident is the record owner of the following described property, to-wit:

Lots 9 and 10 of BLock 6 of the Hubbard Terrace Addition to the City of Urbana, Champaign County, Illinois,

Commonly known as 511 West Delaware, Urbana, Illinois. (93-21-17-379-001); and

WHEREAS, Resident has purchased or become sole owner of the above said property on the 25th day of April , 1981 , and thus was never given the opportunity to be a part of the Carle Park Sewer Project; and

Section 3. That for and in consideration of the above promises by the City, Resident shall pay to the City of Urbana at 400 South Vine Street, Urbana, Illinois, the total sum of \$1,557.00 plus interest at 10% per annum from April 12, 1982 until the said amount is paid in full. Resident

agrees to pay the sum of \$155.70 plus the interest due to date of payment on the 1st day of January, 1983, and a like sum, together with interest due, on the 1st day of January of each and every year thereafter until the entire amount including interest is paid in full. Resident shall have the privilege of prepaying any amount on said indebtedness at any time.

Section 4. That to secure payment of the above said amounts to the City of Urbana, Resident herewith grants to the City of Urbana a lien against the subject premises, which said lien may be foreclosed, in the event of default, in the same manner as is provided by Illinois statutes for foreclosure sale of mechanic's liens.

Section 5. Resident agrees that if the entire amount due and owing to the City is not paid in full within forty-eight (48) hours of approval by the Urbana City Council, the City may record a copy of this Agreement with the Recorder of Deeds of Champaign County, Illinois.
