

RESOLUTION NO. 8283-R7

A RESOLUTION
CONCERNING THE REPORT AND PROPOSAL FROM THE
CHAMPAIGN-URBANA SOLID WASTE LITTER REDUCTION COMMITTEE

WHEREAS, the Champaign-Urbana Solid Waste Litter Reduction Committee submitted its Report and Proposal, dated March 25, 1982, ("Report and Proposal") to the respective City Councils of the City of Urbana and Champaign, Illinois; and

WHEREAS, a Staff Review of such Report and Proposal, dated July 9, 1982, ("Staff Review") has now been prepared and considered by this City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the City Council of the City of Urbana, Illinois hereby expresses its support for the following recommendations as generally outlined in both the Report and Proposal and the Staff Review:

a) That recycling efforts should be a part of the total response to problems associated with solid waste in both the Cities of Urbana and Champaign.

b) That any such recycling efforts for and on behalf of the Cities of Urbana and Champaign should be undertaken under the auspices and authority of the Champaign-Urbana Solid Waste Disposal System as heretofore established by intergovernmental agreement between such Cities.

c) That the Champaign-Urbana Solid Waste Disposal System should undertake such recycling efforts by contracting

for the same with the private sector, which such recycling efforts should include:

(i) the maintenance of existing recycling services as are currently in effect in the community including, but not limited to, the recycling of glass, paper, aluminum, tin, bimetal, scrap metal and oil.

(ii) the maintenance, improvement and addition of drop-off collection points for such recyclable material throughout the community.

d) That the Champaign-Urbana Solid Waste Disposal System obtain the necessary funding to pay for such recycling efforts to be so provided by contract with the private sector by increasing the landfill tipping fee by an amount not exceeding 15 cents per cubic yard for the maintenance of existing recycling services and 3 cents per cubic yard for the maintenance, improvement and addition of drop-off collection points, for a total combined increase in the landfill tipping fee of an amount not exceeding 18 cents per cubic yard.

Section 2. That the appropriate officials of the City of Urbana, Illinois cause a copy of this resolution to be forwarded to the City Council of the City of Champaign, Illinois for the use and consideration of that City Council in making its own independent evaluation of the Report and Proposal and Staff Review.
