A RESOLUTION AMENDING THE URBANA HOME CONSORTIUM AND CITY OF URBANA CONSOLIDATED PLAN FOR PROGRAM YEARS 1995-1999

WHEREAS, the City of Urbana has been designated an entitlement city under the Federal Housing and Community Development Act of 1974, as amended, and as such is eligible for Community Development Block Grant (hereinafter "CDBG") funds upon proper submittal being made to the United States Department of Housing and Urban Development (hereinafter "HUD"); and

WHEREAS, the City of Urbana has been designated lead entity for the Urbana HOME Consortium in accordance with the Cranston-Gonzales National Affordable Housing Act of 1990, as amended, and as such is eligible to receive HOME Investment Partnerships (hereinafter "HOME") funds on behalf of the City of Urbana, City of Champaign, and Champaign County; and

WHEREAS, on January 5, 1995, HUD published a final rule in the Federal Register providing for a consolidated plan for all HUD community planning and development formula grant programs, consolidating into a single submission the planning, application, and reporting aspects of the CDBG, HOME, Emergency Shelter Grants, and Housing Opportunities for Persons With AIDS programs, and the Comprehensive Housing Affordability Strategy; and

WHEREAS, on May 15, 1995, the Urbana City Council approved the Urbana HOME Consortium and the City of Urbana Consolidated Plan for Program Years 1995-1999 (hereinafter the "Consolidated Plan") and authorized submittal of said Consolidated Plan to HUD; and WHEREAS, HUD has subsequently approved said Consolidated Plan and released FY 1995-1996 Community Development Block Grant and HOME funds to the City; and

WHEREAS, the Urbana Community Development Commission assisted by Urbana Grants Management Division staff has prepared an amendment to said Consolidated Plan for public review; and

WHEREAS, said Consolidated Plan amendment was placed on file for public review beginning January 25, 1996 and ending February 23, 1996; and

WHEREAS, a public hearing to solicit input on the Consolidated Plan amendment was held on January 23, 1996; and

WHEREAS, the Urbana Community Development Commission recommended the Consolidated Plan amendment to the Urbana City Council at its January 23, 1996, meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1</u>. That the amendment to the Urbana HOME Consortium and the City of Urbana Consolidated Plan for Program Years 1995-1999, as attached hereto and incorporated herein by reference, is hereby approved.

Section 2. That the Mayor is hereby designated as the authorized representative of the City of Urbana to take any action necessary in conjunction with said Consolidated Plan amendment, including approval and execution of subgrantee agreements and submittal of said Consolidated Plan amendment to HUD.
