A RESOLUTION

APPROVING THE URBANA HOME CONSORTIUM AND CITY OF URBANA
CONSOLIDATED PLAN FOR PROGRAM YEARS 2000-2004
AND AUTHORIZING ITS SUBMITTAL TO THE
U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

WHEREAS, the City of Urbana has been designated an entitlement city under the Federal Housing and Community Development Act of 1974, as amended, and as such is eligible for Community Development Block Grant (hereinafter "CDBG") funds upon proper submittal being made to the United States

Department of Housing and Urban Development (hereinafter "HUD"); and

WHEREAS, the City of Urbana has been designated lead entity for the Urbana HOME Consortium in accordance with the Cranston-Gonzales National Affordable Housing Act of 1990, as amended, and as such is eligible to receive HOME Investment Partnerships (hereinafter "HOME") funds on behalf of the City of Urbana, City of Champaign, Village of Rantoul, and Champaign County; and

WHEREAS, on January 5, 1995, HUD published a final rule in the Federal Register providing for a consolidated plan for all HUD community planning and development formula grant programs, consolidating into a single submission the planning, application, and reporting aspects of the CDBG, HOME, Emergency Shelter Grants, and Housing Opportunities for Persons With AIDS programs, and the Comprehensive Housing Affordability Strategy; and

WHEREAS, the Urbana Community Development Commission sponsored public hearings to solicit input on the Consolidated Plan on December 13, 14, 15, and 16, 1999; and

WHEREAS, the Urbana Community Development Commission assisted by the Urbana Grants Management Division staff has prepared the Urbana HOME Consortium and the City of Urbana Consolidated Plan for Program Years 2000-2004 (hereinafter the "Consolidated Plan") for public review; and

WHEREAS, said Consolidated Plan was placed on file for public review beginning February 15, 2000, and ending March 15, 2000; and

WHEREAS, the Urbana Community Development Commission sponsored two public hearings on March 16, 2000 to receive comments on the draft consolidated plan document; and

WHEREAS, the Urbana Community Development Commission recommended the Consolidated Plan to the Urbana City Council at its March 28, 2000, meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the <u>Urbana HOME Consortium and the City of Urbana</u>

Consolidated Plan for Program Years 2000-2004, as attached hereto and incorporated herein by reference, is hereby approved.

Section 2. That the Mayor is hereby designated as the authorized representative of the City of Urbana to take any action necessary in conjunction with said Consolidated Plan, including certifying consistency with the Consolidated Plan by the City of Urbana as well as other grant program applicants deemed appropriate, approval and execution of subrecipient agreements identified in the Consolidated Plan necessary to implement the CDBG and HOME programs, and to provide such additional information as may be required.
