WHEREAS, pursuant to the requirements of 5 ILCS 120/2.6(c), the City Council has met in closed session to review all closed session minutes; and

WHEREAS, the City Council has determined that the minutes of the meetings listed on Schedule A, attached hereto, no longer require confidential treatment and should be made available for public inspection; and

WHEREAS, the City Council has further determined that a need for confidentiality still exist as to the closed session minutes from the meetings set forth on Schedule B, attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The closed session minutes from those meetings set forth on Schedule A, attached hereto, are hereby released.

Section 2. The City Clerk is hereby authorized and directed to make said minutes available for inspection and copying in accordance with the standing procedures of the Clerk's office.

Section 3. This resolution shall be in full force and effect from and after its passage and approval according to law.
