A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF CHAMPAIGN, THE VILLAGE OF SAVOY, AND THE CHAMPAIGN-URBANA PUBLIC HEALTH DISTRICT FOR THE CULEX MOSQUITO PREVENTION PROGRAM

WHEREAS, the City of Urbana has a population of more than 25,000 and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970 and 65 ILCS 5/1-1-10; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/1, et. seq.) and Article VII, \$10 of the Constitution of the State of Illinois both authorize the above-referenced public entities to contract with one another to perform and share services in any manner not prohibited by law; and

WHEREAS, the Cities, the Village, and the District wish to safeguard against the spread of the West Nile virus and St. Louis encephalitis; and

WHEREAS, the Cities, the Village, and the District wish to prevent and abate the breeding sites for mosquitoes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the INTERGOVERNMENTAL AGREEMENT BETWEEN THE CHAMPAIGN-URBANA PUBLIC HEALTH DISTRICT, THE CITY OF CHAMPAIGN, THE CITY OF URBANA AND THE VILLAGE OF SAVOY FOR THE CULEX MOSQUITO PREVENTION PROGRAM, in substantially the form of the copy of said Agreement, attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 2. That the Mayor of the City of Urbana, Illinois, be, and the same is, hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be, and the same is, hereby authorized to attest to said execution of said Agreement as so authorized and approved for and on behalf of the City of Urbana, Illinois.

Section 3. That the Mayor is authorized to take such actions as are required of the City under the Agreement.
