## RESOLUTION NO. 2014-06-034R

## A RESOLUTION AUTHORIZING THE EXECUTION OF A LAW ENFORCEMENT MUTUAL AID AGREEMENT AND THE EXISTENCE AND FORMATION OF THE ILLINOIS LAW ENFORCEMENT ALARM SYSTEM ("ILEAS")

(Intergovernmental Agreement for Law Enforcement Mutual Aid)

WHEREAS, the City of Urbana (the "City") is an Illinois home rule unit of local government pursuant to Section 6 of Article VII of the Illinois Constitution of 1970 and the statutes of the State of Illinois; and

WHEREAS, the City is authorized and empowered by Section 10 of Article VII of the Illinois Constitution of 1970 and the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.) to enter into intergovernmental agreements with other units of government on matters of mutual concern and interest such as the provision of adequate law enforcement personnel and resources for the protection of residents and property; and

WHEREAS, the City recognizes that certain natural and man-made occurrences may result in emergencies or disasters that exceed the resources, equipment and/or law enforcement personnel of a single given unit of government; and

WHEREAS, a given unit of government can, by entering into a mutual aid agreement for law enforcement such as the Illinois Law Enforcement Alarm System, effectively provide a broader range and more plentiful resources for the citizenry which need and deserve the deployment of such resources; and

WHEREAS, in order to have an effective mutual aid agreement for law enforcement resources and services, the City recognizes that it must be prepared to come to the aid of other units of government in their respective times of need due to emergencies and/or disasters which arise or may arise from time to time; and

WHEREAS, the City recognizes the need for it to develop and participate in an effective mutual aid agreement for law enforcement services and resources upon which it may call upon in its time of need; and

WHEREAS, the City recognizes that, given the number of units of government which have, heretofore, participated and which will participate in this intergovernmental agreement to provide mutual aid of law enforcement services and resources, a public agency must be created and maintained which can effectively, efficiently, and economically coordinate calls for and the deployment of mutual aid law enforcement services and resources on an asneeded basis.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Urbana, Illinois, as follows:

Section 1: A Law Enforcement Mutual Aid Agreement and the Existence and Formation of the Illinois Law Enforcement Alarm System, an intergovernmental agreement in substantially the form attached to this Resolution, be and the same is hereby authorized and approved.

Section 2: The Mayor of the City of Urbana, Illinois, shall be and hereby is authorized to execute on behalf of the City of Urbana, Illinois and to deliver to the City Clerk of the City of Urbana, Illinois, the latter being and the same being so authorized to attest to said execution as so authorized and approved for and on behalf of the city of Urbana, Illinois.
