

**RESOLUTION NO. 2017-06-041R**

**A RESOLUTION RELATING TO PARTICIPATION BY ELECTED OFFICIALS IN  
THE ILLINOIS MUNICIPAL RETIREMENT FUND**

**(2017)**

**WHEREAS**, the City of Urbana, IMRF Employer Number 3394, is a participant in the Illinois Municipal Retirement Fund (“IMRF”); and

**WHEREAS**, members of an elected governing body may elect to participate in the IMRF if they are in positions normally requiring performance of duty for 1,000 hours or more per year; and

**WHEREAS**, the City Council can determine what the normal annual hourly requirements of its elected officials are, and should make such determination for the guidance and direction of the Board of Trustees of the IMRF; and

**WHEREAS**, on February 17, 1986, the City Council passed Resolution No. 8586-R21, excluding from participation in the IMRF all officials and employees in positions normally requiring performance of duty for less than 1,000 hours per year; and

**WHEREAS**, the City Council finds that the Mayor and City Clerk are in positions normally requiring performance of duty for 1,000 hours or more per year.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS**, as follows:

**Section 1.**

The following elected positions qualify for membership in IMRF:

Mayor	May 1, 1989
City Clerk	May 3, 1993

**Section 2.**

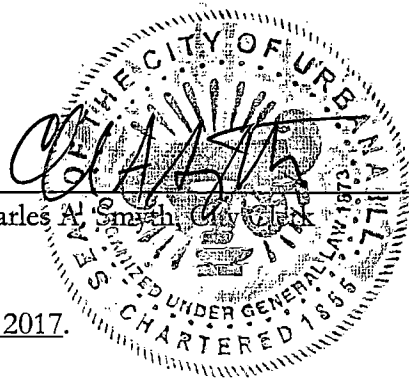


