

**RESOLUTION NO. 2023-05-042R**

**A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF A  
SUBRECIPIENT AGREEMENT STATE OF ILLINOIS DEPARTMENT OF  
COMMERCE AND ECONOMIC OPPORTUNITY AGREEMENT – EAST CENTRAL  
ILLINOIS MUTUAL ASSISTANCE CENTER – NEWCOMER IMMIGRANT STUDENT  
SUPPORT**

**WHEREAS**, the City of Urbana (the “City”) is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, and the passage of this Resolution constitutes an exercise of the City’s home rule powers and functions as granted in the Illinois Constitution, 1970; and

**WHEREAS**, the State of Illinois Department of Commerce and Economic Opportunity (the DCEO) has awarded a grant (“Grant”) in the amount of \$2,000,000 to the City for community development, violence prevention, and administrative costs; and

**WHEREAS**, on September 26, 2022, the Urbana City Council passed Resolution No. 2022-09-074R approving the acceptance of the DCEO Grant; and

**WHEREAS**, East Central Illinois Mutual Assistance Center has heretofore expressed their intent to operate a Newcomer Immigrant Student Support utilizing DCEO violence prevention funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:**

Section 1. That an Agreement providing fifteen thousand and 00/100 dollars (\$15,000.00) to East Central Illinois Mutual Assistance Center so as to operate and administer Newcomer Immigrant Student Support in substantially the same form of said Agreement attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.



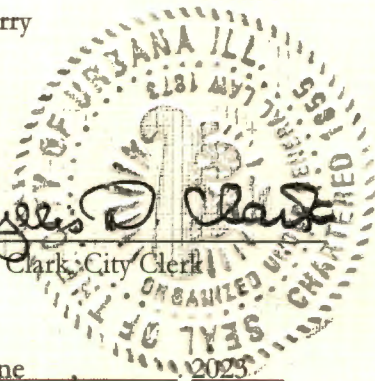


